Applicant further expressly understands and acknowledges that Ram Alloys will rely upon technical documents furnished by Applicant (e.g. specifications, drawings, etc.) in connection with any purchase order. Applicant represents it has the necessary authority and rights to use and distribute any such technical information.
- Applicant shall immediately inspect and examine materials furnished by Ram Alloys upon receipt and promptly report any defects to Ram Alloys in writing within 10 days of receipt or the minimum time requirements required by law, whichever is longer. Ram Alloys' liability is limited to replacement costs. Neither party shall be liable to the other for liquidated, punitive, or consequential damages; lost profits; or lost processing or machine time.
